Statement of Financial Responsibility

Prior Balances:

Prior to a student enrolling, any unpaid balances from prior year(s) at KAES or any other Texas Conference school, including but not limited to: Tuition, After School Care, Music, and/or Cafeteria, must be paid in full.

Collection Policy:

- Tuition is due on the 1st of each month (August – May).
- Tuition paid in full by the 5th of each month will receive a \$5 discount per student.
- Tuition not paid by the 20th of each month will be subject to a \$25 late fee per student.
- Tuition not paid by the end of each month will be subject to the guidelines below.

Payment Police:

In the event your account remains unpaid by the 20th day of the month, one or both parents must meet with the KAES Principal and/or School Treasurer and present an adequate explanation as to why the payment has not been made. If it is determined that severe and unusual circumstances exist, special arrangements must be made for a short-term delay in payment of the account. In the absence of such approved arrangements for delayed payment, the student will no longer be eligible to attend KAES.

All special arrangements must be approved by the KAES Finance Committee.
